# Joseph Education Institute History and Profile

## 1. JEI Background

Joseph Education Institute (JEI) is a private institute set up in 2015. The goal of this institute is to provide various entrepreneurship, management and marketing programs and correspondent Catholic theological subjects designed to equip students with the tools required to prosper in the business world. The Institute also focuses on making positive impacts within the community and the country through many diverse individual students. The Catholic Church in Myanmar has entered her presence of 500 years by celebrating her joyful manifestation in 2014 in Yangon. However, Myanmar Catholic Church has been focusing on theological formation for priests and lay people are still away from such attention.

Therefore instead of waiting her initiatives, by virtue of my baptismal confirmation, I have a responsibility, assigned by Jesus Christ (cfr. Mt 28:18-20), to set up this institute to educate, enhance and empower our Catholic lay people in the mission of her global evangelization. The students are typically mixed mid-career executives pursuing marketing and management and theological diploma programs from JEI. The institute has over 100 students currently enrolled at JEI since 2015. While the name JEI has been becoming more and more reputable within the context of theological education establishments in Yangon, most of the success in finding students comes from word-of-mouth and advertisement from monthly journal recommendations of the old students. Last year, in 2016, we achieved over 100% growth in student numbers.

## 2. About Founder

Kung Za Hmung @ Win Hlaing Oo (Joseph) is an entrepreneur, humanitarian worker and educator with an active interest in promoting the role and responsibility of business organizations in Myanmar's development.

He holds L.L.B. from Yadarnapon University. He finished Christian Philosophy in the Catholic Institute of Philosophy in 2000 and he studied Sacred Theology in 2001 in the Catholic Major Seminary, Yangon. In 2010, he studied political science in the University of York, UK. Now he is doing a Master degree of Business Administration, Assumption University of Thailand in Yangon Campus, Myanmar.



He is now the founding director of **CAD (Community Agency for Rural Development)** which is Myanmar based Non-governmental Organization since 2004. Under his leadership, there are about 50 staffs who are spearheading community development programs (agriculture, farmers' capacity building, community drinking water, weir construction, irrigation facilities, vocational trainings for women and girls, community health education, road and bridge construction, school construction, seed and farming tools support to farmers, researchers, civic education and community based nursery schools) across the remote country where neither UN agency nor International NGO is existent at all.

To add, he is also a publisher and chief-editor of Gloria News Journal in Burmese since 2013. This media is a monthly journal, streamlining on Global Catholic news and teachings on moral, social and spiritual issues, educating civil and religious laws to readers.

Finally, he is also the founding principle of Joseph Education Institute (JEI) since 2015. This institute is providing theological education to lay people in Myanmar and management trainings to people who are also builders of the societies and Myanmar. During these two years, there are already 154 students who are doing a distant theological studies. The final plan is to open a residential program of Joseph University in 20 years.

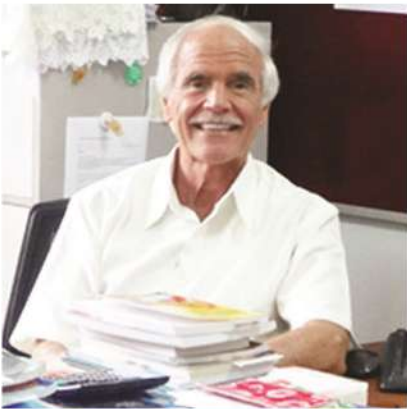

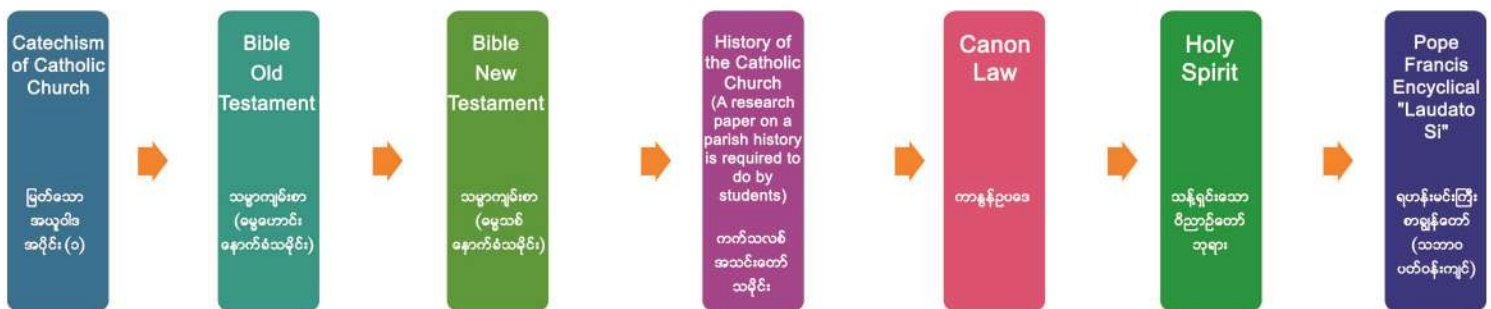

# First Education Workshop

We held a first meeting with our learners (students) who are around Yangon to hear their voices and feedbacks on our correspondent education system on 18 September 2016 at Summit Parkview Hotel. From this first workshop with learners, we discovered the following issues to be continued, improved and extended.



## Their Suggestions:

- They want more qualified instructors in JEI.
- They want more subjects in this course.
- They want to continue from diploma course to bachelor degrees in future.
- They want us to open JEI University in future.

## Their Feedbacks:

- They said the course is more than catechism class and they come to have a deeper knowledge on nature and work of *Holy Spirit, Canon Law, Church History, Catechism of Catholic Church, Laudato Si* for humanity.
- They said they are no more normal persons before joining JEI which means after joining JEI course, they become better theological knowledge equipped.
- They said they have more courage to do evangelization (sharing what they know from our course to others).
- On papal encyclical of Laudato Si (Our Common Home), from learning responsibility of each person on environment from the encyclical of Pope Francis, they said they have changed their behavior of throwing wastes on road to dustbin.

On Reverse Side

Conditions & Directives to be followed by the Entrepreneur Permitted to run the Business

- The entrepreneur holding work permit shall not commit any disturbance to the public in the environment residing around the place relating with his work.
- The Business Licence shall be free from ownership dispute and shall not be entangled with personal claims or objectives.
- Party holding permit to do the business, shall follow strictly existing laws & Rules provided, Directives and also Orders and Directives issued occasionally by Administrative Organizations and Directives, Orders and Terms & Conditions and Procedures promulgated by the Ministry & Administration Organizations the entrepreneur has to keep registration on the work permit order issued by those Departments & Organizations in hand.
- For running business which has to follow laws and rules provided by the Ministry & Administration Organizations the entrepreneur has to keep registration on the work permit order issued by those Departments & Organizations in hand.
- Work Permit holder shall take measures on arranging in keeping drinking water/utility water making arrangement for cleaning, discarding refuse so as to prevent diseases, security, and beauty of the City, safety and health of workers/customers, avoiding traffic jamming and protection of fire hazard. And also shall follow these arrangement exactly.
- Raw materials used in production, keeping in stock, and also those displayed and distributed to the public shall meet specification specified by the Ministry, Concern and the Organization and the Department Concern. And besides the licence holder shall take measure on the product so as to be free from danger to the consumers and has to need health and safety of the consumers.
- License holder shall accept inspection of permitted business by the authority concern at all time. And also he shall level his performance related with business to the inspectors.
- If the licence holder, according to any requirement, shall be directed by the authority to move from the place he shall follow the directive immediately.
- If the licence holder violates certain conditions as mentioned above or fail to follow the conditions prescribed, the licence shall be terminated or shall be revoked under administrative publication, if necessary he shall be dealt with according to Law. During time of the revoking and under the period of taking punishment, although matters dispute with workers shall exclusively concern with the licence holder.
